I. GENERAL DESCRIPTION of CENTER:

The mission of Metrocare Services is to serve our neighbors with developmental or mental health challenges by helping them find lives that are meaningful and satisfying. We are an agency committed to quality gender-responsive, trauma-informed care to individuals experiencing serious mental illness, development disabilities, and co-occurring disorders. Metrocare programs focus on the issues that matter most in the lives of the children, families, and adults we serve.

II. OVERALL PROJECT OBJECTIVES

Metrocare has several divisions, including Mental Health, Local Intellectual and Developmental Disability Authority, Homeless and Housing Services, and Veterans and Military Family Services who are interested in purchasing a clinical augmented intelligence system that supports better care delivery by capturing the clinical session conversation and then assembles a progress note that is presented to the provider for review and aides in the completion of the required documentation for the encounter.

III. SPECIFICATION OF DELIVERABLES

The preferred application will utilize clinical intelligence to capture key points in the clinical session and assist the clinician with the required documentation for the encounter. An overview of the services provided by the vendor should include a detailed description of each of the following minimum capabilities:

- Clinically proven ambient listening capability using either a static or mobile listening device for a minimum of a year.
- EMR agnostic and able to integrate with Netsmart MyAvatar
- Can be mapped to current progress note formats.
- Manual note entry supports multiple languages

IV. PROPOSAL REQUIREMENTS:

A submission must, at a minimum, include the following elements:

- Description of your firm including general overview, names and credentials of team members
- Description of the functionality of the solution
- A brief description of the firm's strengths, related experience and skills or capabilities as they might relate to Metrocare Services
- Define any hardware/specific system requirements
- Outline of the implementation process to be used
- Data pertaining to potential time savings for our clinicians
- Pricing Breakdown for services offered
- Timeline of project (estimate)

VI. DESCRIPTION OF THE RFP PROCESS

b. Step 2 – Selection and Recommendation Stage

The RFP Committee will select a provider to deliver and facilitate the implementation of the clinical AI system for Metrocare. Staff will then seek final approval from Metrocare's Executive Committee.
